Ship Run is a free to play endless flyer meant to bring easy and fun entertainment to our users. Our Privacy Policy explains what information is collected throughout the application. For example, information regarding an individual's personal scores and Game Center account is recorded throughout the users interaction with the application.

When we say "Ship Run," "our," "we," or "us," we're talking about the developer. This Privacy Policy applies to the mobile application Ship Run.

### **Information We Collect**

Ship Run collects information regarding the users individual score and amount of coins collected while they use the application. The user can also provide their own personal Game Center account which will be used to keep track of their individual score, that will then be uploaded to a global leaderboard.

### **Information You Provide**

- When the application is first launched the user will be asked to sign into their personal Game Center account which will be used to record data for our global leaderboard. If the user does not want to provide this information they can do so, and the application will be able to run accordingly.

### **Automatically Collected Information**

- We collect Personal User Data. Such as their individual scores and coins collected while they use the application
- Device Information. We collect specific device information as the individual uses our application. This data is recorded purely for styling purposes of the application to maintain a fluid and pleasuring user experience.

### **Third-Party Information**

Third Party Providers. We work with third-party providers in order to provide in-app advertisements to the user. The data collected from these third-party sources are purely about the users interactions with these advertisements such as impressions.

### **How We Use Information**

The information our application collects is purely to better understand and encourage a more competitive user environment. By introducing a global leaderboard we hope to motivate individuals to try for better scores within our game in order to beat the competition: such as friends, family, and other users around the world.

## **Managing Your Information**

If you would like to delete all data from Ship Run, you can do that. All you have to do is simply delete the application off of your mobile device in order to delete all of its data. Or if you simply do not want your scores to be given to Game Center just simply decline when prompted to sign into your personal Game Center account.
